2023 Soccer Year Discussion – Tim & Kevin

- Kickers/In House will be looking to tweak these programs for fall. Looking to shorten program time to match the attention of the younger players. Also potentially looking at alternate scheduling with shorter sessions. Would allow stronger coaches to work back to back groups.
- Program time adjustment for Kickers Preschool reduced to 30 minutes and Kindergarten reduced to 45 minutes
- Competitive fees increase by \$25 per player to cover increased club fees
- Looking at increasing referee fees in order to get referees
- No Recreation Director as of Fall 2022 (need new director before July 2022)
- Fall programs Registration should be posted before Spring session ends
